# HOUSING & RENTERS' RIGHTS

#### **EVICTION DEFENSE**

Staff and volunteers defend lowincome tenants against eviction. Program available in Syracuse City Court and East Syracuse Justice Court.

#### TENANTS' RIGHTS COUNSELING
