BEHIND THE WORK

Our team of **29** dedicated staff and more than **600** volunteers—attorneys, law students, paralegals, undergraduate students, and interpreters—worked together to make equity and justice real for people across Central and Upstate New York. In just the past year, we served over **4,000** clients, touching the lives of more than **10,000** people in our community.



EQUITY IN ACTION

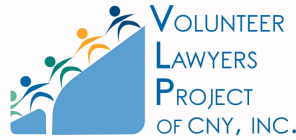
Every day, we help:

- Tenants avoid eviction
- Survivors of domestic violence find safety
- Immigrants secure stability
- Transgender people live with dignity and avoid discrimination
- Families fight unjust debt
- People with nowhere else to turn



Together, we:

- ★ Represented a single father of a one-year-old - who relies on a vital support network in his building - maintain his housing while facing eviction. We raised significant habitability issues, and the court ordered the landlord to make repairs and excused the client from paying rent until the work is completed.
- ★ Helped an Afghan client win asylum. We assisted in filing his adjustment application and accompanied him to his September interview, where he was granted permanent residency. This is one of several green card approvals our team secured this year in Syracuse and the North Country.
- ★ Worked with an elderly client with disabilities and only Social Security Disability income by drafting his first will. He couldn't afford an attorney and wanted to leave his few belongings to his brother. The client said he was thrilled to receive free help and felt at peace knowing his brother will be able to inherit his belongings more easily.



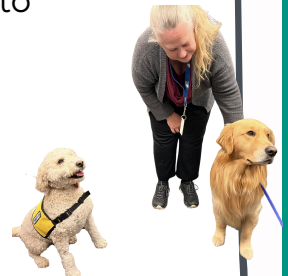
